ENFORCEMENT OF COURT ORDERS (LEGAL AID) (AMENDMENT)  
REGULATIONS 2011

I, ALAN SHATTER, Minister for Justice and Equality, in exercise of the powers conferred on me by subsection (4) of section 6A (inserted by section 2 of the Enforcement of Court Orders (Amendment) Act 2009 (No. 21 of 2009)) of the Enforcement of Court Orders Act 1940 (No. 23 of 1940) (as adapted by the Justice and Law Reform (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 138 of 2011)), and in so far as the following regulations relate to the rate of payments of fees payable out of moneys provided by the Oireachtas pursuant to certificates for free legal aid with the consent of the Minister for Finance, make the following regulations:

1. (1) These Regulations may be cited as the Enforcement of Court Orders (Legal Aid) (Amendment) Regulations 2011.

(2) These Regulations shall come into operation on 13 July 2011.

2. In these Regulations “Principal Regulations” means the Enforcement of Court Orders (Legal Aid) Regulations 2009 (S.I. No. 301 of 2009).

3. The Principal Regulations are amended by substituting the following Schedule for Schedule 2:

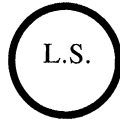

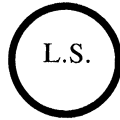
